

Thanks For your Vote of Confidence. I want to thank the membership for electing me to a third term. I congratulate all the newly-elected officers of the CWV and the Auxiliary. My thanks to our past officers for their work and dedication to our organization.

APPOINTMENTS

Several officers were appointed at the National Convention. Our Chaplain remains Msgr. Edward Coyle; Executive Director is David Crum; Adjutant is Nicholas Taylor; Jose Garcia, PNC continues as our National Service Officer. The offices of National Liaison, Auxiliary

Liaison and National VAVS were offered to Marvin McFeaters, Julian Mendoza, Denise DeBlois and Manuel Tanguma, PNC, who declined appointment for various reasons. These offices remain vacant, and I will consider anyone who wishes to be of service. Please contact me if you have an interest or know of someone who might be a good candidate.

UNIFORMS

Please take note and heed as new uniform regulations will be strictly enforced as of 1 January 2020, unless due to extenuating circumstances approved by the National Commander beforehand.

MEN: FORMAL/DRESS Uniforms will be a Navy Blue single breasted sport coat/jacket, khaki (tan) pants/slacks, white shirt (short or long sleeve depending on weather), CWV tie, CWV garrison cap and dress shoes. CASUAL Uniform will be khaki (tan) pants/slacks, CWV polo shirt, and garrison cap.

The appropriate uniform MUST be worn for our various meetings and events. If anyone has a question concerning the correct uniform, please refer to your event guide or ask one of the National Committee Officers. While we do appreciate that many of you are also involved with other organizations such as the DAV, VFW, etc., we require that when attending any CWV function, you be attired in our CWV uniform.

AUXILIARY: FORMAL/DRESS Uniform: A motion was made and passed that all auxiliary members will now wear black dress pants/slacks. Until further notice, the light blue blazer/jacket, white jewel neckline blouse (men are to wear white dress shirt, short or long sleeve), garrison cap and black shoes (no high heels) will be worn. Jewelry should be confined to CWVA earrings or small pearl. Any handbag is to be black. Please remember to have white gloves needed for certain functions, rites or ceremonies. CASUAL Uniform will use the CWVA polo shirt. As with CWV members, please be aware of the dress code for the functions which you will be attending.

UNACCEPTABLE BEHAVIOR WILL NOT BE TOLERATED

And now for something it is necessary for me to address. It was brought to my attention there were incidents of unacceptable behavior on the part of some members at our convention. The complaints alleged harassment and bullying. No specific persons were named and the incidents could not be verified or proven, but are being addressed. RAMIRO GOMEZ DEPARTMENT OF TEXAS

A 52-year member of the Catholic War Veterans, Ramiro Gomez has been involved in his parish Church and school, and programs sponsoring Patriotism, Youth, Catholicism and Veterans. He is a member of Jose Tolento Post 1109 in San Benito, Texas since 1947.

He has served his Post and the Department of Texas in various offices since the 1960's, attending state and national conventions, particularly active for an 87-year-old Korean War Veteran. He maintains the Department's accounting and


NATIONAL WORLD WAR I MEMORIAL TAKES SHAPE IN WASHINGTON

The National World War I Centennial Commission is rushing to have the National WWI Memorial completed by Victory in Europe Day 2020. It will be located in Pershing Park, a 1.76-acre landscape set along Pennsylvania Avenue in Washington, D.C. just steps away from the White House. Designed by sculptor Sabin Howard, "A Soldier's Journey" is a massive 60-foot-long, 10-feet-high bronze figure sculpture which will be the centerpiece of the memorial.


The concept is to allow people to walk up close to the relief sculpture—a moment on the site that Howard was keen on highlighting. The story unfolds before the viewer's eyes—a person of average height will see the knees of the figures straight on. "I want people to have a visceral reaction to this," Howard said. "It reads like a film."

Though the sculpture seems traditional, Howard utilized a contemporary process called photogrammetry to create it. He took images with his cell phone of actors portraying scenes from wartime and then combined the individual shots to find the pattern that would create the best flow for the visual story. It took him 12 versions, done over nine months, to determine the final relief. From there, he spent 700 hours over two months drawing a detailed mock-up of the piece.

"For this part, I wasn't even sculpting," Howard said. "I was creating a hierarchical construction, a system of design that we could break down to do the sculpture quickly." This kind of commission, he said, is something that would have taken him 15 years to complete, but he's been charged with doing it in four. He'll be working with the Pangolin Editions sculpture foundry in England to assemble the figure molds.








NEW YORK CITY NEIGHBORHOODS COMMEMORATE WORLD WAR I 100 YEARS LATER!

PRESIDENT TRUMP SIGNS blue water navy vietnam veterans act of 2019

The Blue Water Navy Vietnam Veterans Act of 2019 restores VA benefits to thousands of Blue Water Navy Vietnam veterans who had their disability eligibility taken away in 2002 after arbitrary regulatory changes.

It benefits veterans exposed to Agent Orange while serving along the Korean DMZ with an earlier start date to encompass the timeframe various defoliants were tested to September 1, 1967, instead of April 1, 1968 - and expands benefits to children born with spina bifida due to a parent's exposure in Thailand, coverage that already exists for the children of Vietnam and Korean DMZ veterans. The new law also requires the VA to report on research being conducted on a broad range of conditions possibly related to service in Southwest Asia, which is important for future legislative efforts to create a list of presumptive conditions for veterans seeking VA health care and benefits. The legislation was passed unanimously by the House and had been the focus of advocates fighting to ensure nearly 90,000 veterans who served on ships around Vietnam are granted the same Veterans Affairs benefits status, given the lack of chemical monitoring on the ships at the time and the decades that have passed since the exposure.

U.S. SUPREME COURT ISSUES RULINGS OF INTEREST

Our National Commander has brought to our attention some recent important decisions handed down by the U.S. Supreme Court.

A decision was made to ban Sharia Law and Islam from being taught in

our public schools. Justice Neil Gorsuch wrote: "The government certainly has no business being involved in religion, but this isn't a government of a religious issue. This is about the judicial branch interpreting the laws as they apply to the teaching of religion. We shouldn't be teaching any religions in the public schools of this country."

Also rejected was an atheist's case to remove "In God We Trust," our national motto, from all coins and currency issued by the Department of the Treasury. This is the same person who tried earlier to have "Under God" removed from our Pledge of Allegiance. This was also rejected.

A ruling was also issued in the case of a 40-foot World War I memorial cross on public land located in Bladensburg, Maryland. In a 7-2 vote, the justices affirmed that the cross could remain on public land. Justices Ginsburg and Sotomayor dissented.



GRUMMAN EA-6B PROWLER Inducted into National Air and Space Museum

This venerable Grumman plane was recently inducted into Smithsonian National Air and Space Museum at the Steven F. Udvar-Hazy Center in Chantilly, Virginia. The Prowler was the first U.S. military aircraft specifically designed for tactical electronic warfare—jamming enemy radar and communications while escorting aircraft on strike and bombing missions. Electronic warfare is a nebulous thing. Unlike more traditional warfare (where things are shot down or blown up), it is not obvious when it works, and the results are fleeting. For nearly 50 years, the Prowler was a master of this type of warfare; the premier tactical jamming aircraft in the world, adapting to and often defining the nature of airborne electronic warfare.



MEMORIAL PLANNED TO IMPORTANT COLD WAR FIGURE FRANCIS GARY POWERS ~ PILOT, SPY, HERO!

On May 1, 1960 the Soviets shot down his CIA U-2 spy plane. After three months of solitary confinement and interrogations, he was tried and sentenced to 10 years in a Soviet prison. Then he was traded for a Russian spy and went home to his family. Upon his return home he was cleared by the CIA and US Senate and shown to be "A fine young man performing well under dangerous circumstance."

Between 1963 and 1970 he worked as a Lockheed test pilot flying out of Burbank Airport. In 1970 he wrote his autobiography "Operation Overflight"

before getting a job in 1972 with KGIL in the San Fernando Valley. He went on to fly helicopters for KNBC News here in Los Angeles. Then on August 1, 1977 after covering a fire in Santa Barbara, on his return trip to the Burbank Airport his aircraft ran out of fuel and crashed.

"Upon my father's return home, despite the CIA and Senate committee's clearance, despite the fact that he was awarded the CIA's highest honor—its Intelligence Star for valor—and the Air Force's Distinguished Flying Cross, my father, to borrow from John Le Carré, was still a spy left out in the cold, until May 1, 2000 and June 12, 2012. On those dates he was posthumously awarded the POW Medal, the National Defense Service Medal, and the CIA's Director's Medal for "extraordinary fidelity and essential service," and then the USAF Silver Star. The Powers family is very humbled and very honored that there is an initiative to erect a monument to keep my father's memory alive for future generations." ~ Francis Gary Powers Jr.
